Course Descriptions

Friday Classes:

Overview of DBPR ECLB License Renewal Process

This presentation provides electrical contractors information regarding options available to them to renew their license(s) during the renewal period. It will include a “walk through” of www.myfloridalicense.com to help them navigate the site. Part 61G6-9.004, Florida Administrative Code, will be covered during the presentation along with a discussion of the most frequently asked questions regarding renewal.

Overview of Florida Laws and Rules - Electrical

This course reviews the Laws (Florida Statutes) found in F. S. Chapter 455, Business & Professional Regulation General Provisions; F. S. Chapter 489 Part II, Electrical and Alarm System Contracting; and Chapter 61G6 of the Florida Administrative Code. It will also identify the role of the Department of Professional Regulation, Electrical Contractors Licensing Board (ECLB) and familiarize contractors of the Definitions of Occupation and Class Codes and “Know Your Scope” chart.

FPL Electric Service Standards Manual Refresher Update

This course is designed to complement FPL Electric Service Standard 101 and 102, both of which have been previously presented by FPL. The content of this course will serve as a refresher and update of changes to the current edition of the Florida Power and Light (FPL) Electrical Service Standards Manual.

Workers Compensation-Managed Risk or Unnecessary Profit Loss

This one-hour course will provide contractors with important information on how to become familiar with and how to manage their Workers' Compensation Program in order to comply with the requirements and take advantage of cost savings initiatives

Distracted Driving – What is Important to You

This one-hour course will provide contractors with important vehicle safety information that will help protect their employees from potentially serious harm as well as safe money by avoiding the high cost of accidents.

Customer Service Customer Care

This course is designed to identify all types of business communication including, but not limited to, face to face; telephonic; written; emails and other technologies. Attendees will take away with them customer service strategies to help create customer service policies that will reduce the number of negative complaints that they receive or that are shared online.

Saturday Classes:

Major Changes to the 2014 NEC

This course identifies and discusses the major changes found in the 2014 National Electric Code (NEC) as well as updates on progress of the upcoming 2017 NEC.

6th Edition Florida Energy Conservation Code

This course walks contractors thru the major changes found in the 6th Edition of the Florida Building Energy Conservation Code.

Major Changes Contained in the 6th Edition (2017) FBC Advanced (859.0)

This advanced course reviews and summarizes changes contained in the 6th Edition (2017), Energy Conservation Code. It is designed to insure understanding of the changes to the code that went into effect at midnight on December 31, 2017.

Preventing False Alarms

This course provides Electrical Contractors with an understanding of the definition of what a false alarm is; why false alarms are a problem; some of the major causes of false alarms; and reviews various Florida Statutes and local municipalities' rules relating to false alarms.
